ABOUT THE GRANT:

The APICDA Gear Reimbursement Grant improves resident's ability to participate in the commercial and/or subsistence fisheries in the communities of Akutan, Atka, False Pass, Nelson Lagoon, Nikolski and St. George. This grant aids residents in obtaining new and efficient gear to maximize their harvest efforts by providing financial assistance in the form of reimbursement of associated costs to APICDA residents who purchase gear for subsistence harvest and/or commercial fishing use.

ELIGIBILITY:

Applicants must meet the following requirements to qualify for reimbursement of gear expenditures:

- 18 years old and physically capable to participate in subsistence and/commercial fisheries.
- Submit a complete application form with all attachments during application period.
- Copy of ID or driver's license.
- Provide documentation of residency in an APICDA community.
- Provide documentation of permit in commercial fishery or subsistence harvest (if required by the state)
- Provide receipts as proof of the cost of gear.
- Provide current contact and banking information for disbursement of funds.

**Application Period March 1 - December 2020**

GRANT DETAILS:

- Applicants may apply for the commercial grant, or the subsistence grant, or both if separate qualified receipts are provided with each application.
- Only permit holders owning/leasing a vessel may submit for the commercial gear grant.
- Deckhands may provide proof of their crew license or SHARC card to qualify for protective gear purchased for commercial fishing.

EXAMPLES OF GEAR APPROVED FOR REIMBURSEMENT:

- Fishing Gear i.e., hooks, line, nets (new or repair expenses), etc.
- Bait
- Personal Protective Gear i.e. gloves, raingear, boots
- Fuel purchased and used for commercial fishing or subsistence harvesting
- Safety equipment i.e., life rafts/jackets/suits, flares, USGC required safety equipment, navigational aids
- Ancillary items used to increase efficiencies and run gear while commercial fishing or subsistence harvesting
- Shipping costs associated with approved gear from vendor to resident

### Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following.

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)
- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.
