

ABOUT APICDA

The Aleutian Pribilof Island Community Development Association (APICDA) is a non-profit dedicated to strengthening local fisheries-based economies by increasing direct fisheries participation in the Bering Sea and Aleutian Islands, building support infrastructure and offering programs to assist the advancement of priority initiatives in its six member communities in the Aleutian-Pribilof region of Alaska.

APICDA is one of six Western Alaska Community
Development Quota (CDQ) groups. The CDQ program
allocates a percentage of all Bering Sea and Aleutian Islands
quotas for ground fish, halibut, and crab to eligible CDQ
groups that represent 65 villages in Alaska. APICDA and
its subsidiary companies generate profits through the
management of the quotas and uses proceeds to achieve
its purpose of sustaining the communities of Akutan, Atka,
False Pass, Nelson Lagoon, Nikolski, and St. George.







FISHERIES PROGRAMS



RESIDENT FISHERIES ACCESS PROGRAM

The Resident Fisheries Access Program (RFAP) aids residents of the APICDA communities in pursuing opportunities within the commercial fishing industry. As a CDQ Group, APICDA strategically supports local fisheries through diverse programs that:

- 1. Provide residents with access to commercial fisheries in the Bering Sea and Aleutian Islands.
- 2. Create or enhance job opportunities in the Aleutian-Pribilof Region.
- 3. Build business diversity in the APICDA communities and reduce barriers for resident commercial fishermen.

Programs offered under the Resident Fisheries Access Program include:

- IFQ Loan Program
- Atka Halibut Fishery
- · St. George Revolving Loan Program
- St. George Tendering Program
- Fisheries Employment (see Workforce Development section)
- Gear Reimbursement Grant (GRG)
- Vessel Down Payment Support (see GRG)

APICDA allocates grant funds for the Fishermen Associations in our member communities to support fishing priorities at the local level to increase participation in the commercial fishing industry.

Award amounts are determined by the APICDA Board of Directors and have been \$20,000 annually. The funds are used at the discretion of the associations; awards have been used for a variety of projects including funding salmon stream surveys and to start revolving loan funds.

The grant is initiated during the first quarter of each year by APICDA staff sending correspondence to the President of the local association with an outline of the requirements of the program and funding information.

Aligned with the Resident Fisheries Access Program (RFAP), APICDA offers a loan program to support community residents seeking funding to develop their commercial fishing business with the purchase of halibut or sablefish individual fishing quota (IFQ). APICDA has historically supported IFQ purchases and is pleased to introduce a more formalized and structured program. Providing an opportunity for community members to participate and invest in fisheries in the Bering Sea and Aleutian Islands Management Area is fundamental to the CDQ mission.

Each loan process is unique to the borrower and requires the interested borrower to contact APICDA directly for an intake phone call to determine if the applicant is a good fit for the program.

ATKA HALIBUT FISHERY

APICDA aids in the coordination of a walk-on program for resident fishermen to aid them in fully harvesting their individual quota shares and to generate income from their halibut fishery. Currently, this program provides important fisheries access for our local fishermen in Atka by partnering with an area 4B harvester and helping to find a market for their halibut, while largely diminishing traditional lease fees which increases earnings for our local fishermen.

ST. GEORGE REVOLVING LOAN PROGRAM

The Fishermen's Revolving Loan Program offers resident fishermen harvesting CDQ quota in St. George the ability to charge fishing related gear and equipment in advance of the upcoming commercial fishing season. The ability to obtain gear before the start of the season allows fishermen the time to prepare without losing fishing days during the season. This program is currently offered to resident fishermen in St. George.

ST. GEORGE TENDERING PROGRAM

St. George has a very strong historical dependency on the halibut fishery. APICDA provides essential operational and quota management support for resident fishermen in St. George by operating a tendering and lightering service from our AVI vessel to bring their halibut to market.

The local halibut program has provided important income and allowed residents to leverage earnings from CDQ shares to purchase additional IFQ shares.

The Gear Reimbursement Grant (GRG) helps residents of APICDA CDQ member communities who participate in commercial fisheries and subsistence harvesting activities. The goal of the program is to aid residents in obtaining new and efficient gear to maximize their harvest efforts by providing financial assistance in the form of reimbursement for a portion of the incurred costs.

Beginning in 2024, through the Resident Fisheries Access Program (RFAP), the GRG offers vessel down payment assistance to residents of APICDA CDQ member communities. Contact APICDA's office for more information about this program and to pre-qualify.



Examples of Items Approved for Reimbursement:

- Fishing Related Items, i.e. fuel used for commercial fishing or subsistence, bait, gear, personal protective gear, safety equipment, navigational aids, vessel and gear storage, travel lift fees, parts for repairs, replacement or maintenance to vessels, equipment or machinery, and ancillary items used to increase efficiencies while commercial fishing or subsistence harvesting.
- Vessel, skiff or ATV purchase, vessel dry dock repair or maintenance, filters, oil, replacement parts, and moorage.
- Materials for preserving subsistence harvested wild game or seafood, i.e. smokehouse or game shed, freezer, vacuum machine, canning jars.

As a key component for economic growth and development, our education and workforce development programs provide opportunities to advance education, training, and career development to help strengthen the region and support healthy, sustainable communities.

APICDA's collaborative efforts have resulted in the placement of 24 interns over the years within the Qawalangin Tribe, a testament to the enduring impact of this partnership. Moreover, APICDA has invested close to \$90,000 in wages and payroll taxes while supporting the tribe's interns, reflecting our shared commitment to fostering individual growth while ensuring economic benefits for the community of Unalaska.

COLLEGE SCHOLARSHIPS



EMIL BERIKOFF, SR. MEMORIAL SCHOLARSHIP



This program is named in honor of the late Emil Berikoff, Sr. of Unalaska, who served on the APICDA Board for 15 years before passing away in 2011. His contributions as a trusted board member and to the region were invaluable.

The purpose of the Emil Berikoff, Sr. Memorial Scholarship (EBMS) program is to provide scholarship awards to current APICDA community residents and former residents who demonstrate a tie to an APICDA community.

Scholarship Requirements:

- Be a current resident of an APICDA community or a former resident with a tie to an APICDA community.
- Enrolling at an accredited college or university.
- Enrolling in a minimum of 6 credits per semester or 4 credits per quarter.
- Maintain a minimum 2.0 GPA for each term funded.
- Applicants must demonstrate financial need.
- Submit a complete application packet by 5:00 p.m. AKST on one of the published deadlines below.

The GPA Scholarship provides EBMS recipients with the opportunity to secure an additional scholarship by achieving outstanding academic grades. EBMS recipients who earn a 3.5 GPA or higher for the term are eligible to receive the GPA Scholarship based on the following schedule:

- 3.5-3.74 GPA: \$750/term, up to \$1,500 school year
- 3.75-3.99 GPA: \$1,000 term, up to \$2,000 per school year
- 4.00 GPA: \$1,250/term, up to \$2,500 per school year

There is no application for this scholarship.



New in 2024: The GPA Scholarship is open to both full-time and part-time scholarship recipients.



WORK INVEST NOW SCHOLARSHIP

Residents who engage in APICDA's employment opportunities have the chance to gain extra scholarship funds for their education through the Work Invest Now (WIN) Scholarship.

EBMS recipients who work for APICDA or its subsidiary companies, or those who intern with APICDA's internship program are eligible for this \$2,500 scholarship.

Residents ages 14-18 who participate in the youth internship program are eligible to bank \$1,000 each year, up to \$4,000 total, to be awarded during their first year of college or vocational training school.

There is no application for this scholarship.





HAGINAA KIDUL (HELPING TO GROW) COLLEGE SCHOLARSHIP

APICDA and its board of directors recognize the interconnectedness of students, families and communities within the Aleutian-Pribilof region. We believe that expanding access to education and training offerings beyond CDQ member communities will help increase opportunities for networking, collaboration and information sharing, and in turn will help grow and strengthen our regional economy.

The APICDA Board of Directors establishes the number of Haginaa Kidul scholarships available for award each year. This is a competitive scholarship awarded in the amount of \$2,000 per school year. *Applicants who qualify for the EMBS may also apply.



VOCATIONAL TRAINING SCHOLARSHIPS



CAREER & TECHNICAL TRAINING SCHOLARSHIP



The Career and Technical Training (CTT) Scholarship, formerly known as the Supplemental Education Scholarship, provides vocational training and career development scholarships to or for the benefit of APICDA residents.

This scholarship aids residents of the APICDA region in their educational pursuits, supporting them to undertake vocational training or professional development to advance their careers. APICDA utilizes this fund to strengthen economic growth crucial for sustaining our communities.

Scholarship Requirements:

- Be a current resident with intent to remain indefinitely, or a former resident currently employed by a local regional entity whose training will directly benefit the region, or a past resident whose training will assist them in securing a job in an APICDA community.
- Proof of enrollment in a vocational training program or career development program.
- Submit an application no later than 10 business days prior to payment due date.

Scholarships are awarded for any amount up to \$4,000 per calendar year, based on applicants' financial need.

APICDA's Board of Directors recognizes that leadership development comes in many different forms and this grant provides a funding resource to create access for participation in events such as conferences, trainings, or developing mentor/protege partnerships to explore the pathways to grow into a community leader.

The Justine Gundersen Leadership Development Grant supports new and emerging leaders seeking to develop their leadership skills, engage in civic activities, and support succession planning. Applicants may apply for financial support to cover the cost of airfare, hotel, per diem, and registration fees up to \$2,000 per event.

APICDA is committed to fostering workforce development opportunities through its many internship and educational offerings. APICDA's internship program serves as a bridge towards education, employment, and community engagement. Several internships have resulted in full-time employment opportunities at APICDA and with partner organizations.

Three types of internships are available within APICDA, its subsidiaries, partnerships and other organizations affiliated with the region:

- **College Internship** For residents who are entering or enrolled in college. College interns who successfully complete their internship become eligible for the WIN Scholarship (see page 13).
- **Youth Internship** For resident youth ages 14-18. Youth interns who successfully complete their internship become eligible for the WIN Scholarship (see page 13).
- **Employment Internship** This program offers employment opportunities to adult APICDA community residents who are interested in gaining valuable work experience. This program can be a great tool for local community businesses looking to introduce residents to available jobs while receiving financial support from APICDA for intern wages and employer payroll tax liabilities.

Business Partnerships: APICDA partners with local organizations and entities that directly serve the Aleutian-Pribilof region to offer internship opportunities for residents. By partnering with APICDA, hiring organizations can receive wage and employer payroll tax support from APICDA, introduce residents to your organization while filling employment gaps, and create meaningful employment opportunities for community residents.

The School Grant is offered to support our schools and to be used in any manner that will encourage and foster the education of students with regard to the fisheries located adjacent to our shores. The funds may be directed toward fishery conservation or management education, development of vocational programs, special projects, or any educational activity that enhances the awareness of students regarding the fishing industry. Each year APICDA offers a school grant in the amount of \$12,000 to a public school in each CDQ community and Unalaska.

COMMUNITY DEVELOPMENT PROGRAMS

Our community development programs provide a resource to APICDA CDQ member communities of direct financial support and assists with leveraging additional funding for priority initiatives. Each APICDA community has developed a Community Development Plan (CDP) identifying goals for the community. This program assists communities in accomplishing their community development goals.



The Akutan Corporation received a CDGP award of \$150,000 to remodel its Salmonberry Inn. The goal of this project was to renovate the vacant building to create four separate living units to accommodate long-term, low-income renters seeking housing in Akutan. The project helps serve an important need in Akutan, where living spaces are at a short supply, and will provide four families with an affordable, high-quality housing option.

The Native Village of Atka received a CDGP award of \$250,000 to support community housing repairs.

Sarah and Arnold Golodoff (pictured right), residents of Atka, received essential safety repairs for their home, as part of this grant award. The renovations focused on ensuring accessibility and safety. By leveraging CDGP funding, the tribe successfully remodeled the Golodoff's residence, enabling them to continue living in their community while comfortably aging in place. The Community Development Grant Program (CDGP) provides direct financial assistance to support priority initiatives identified by local leadership in the Community Development Plans* (CDP) of APICDA CDQ member communities. Grant funds are available to leverage other funding sources and can be used directly to create jobs, promote economic development, and support essential needs in each community. The grant amount is determined yearly by APICDA's Board of Directors.

The city, village corporation, and tribe are each eligible to apply for funding to pursue projects listed on their CDP, and are requested to coordinate and seek concurrence with one another as part of the application process to ensure that the funded project will have community-wide benefits.

Projects must be listed on the CDP and meet one or more of the requirements below:

- Provide in-region employment
- Aid in the reduction of poverty
- Provide economic and social benefits for community residents
- Aid in creating a sustainable and diversified local economy
- Benefit the fishing industry directly or indirectly
- Benefit all community residents

The CDGP began in 2019 and in 5 years has awarded \$9.5 million dollars for 59 community development projects in APICDA CDQ communities. From the Atka Health Clinic to the Nelson Lagoon Rural Power System Upgrade Project, the CDGP continues to be a successful and popular resource.





APICDA supports our CDQ member communities by focusing on economic development, programs for individual residents and governing entities to achieve sustainable and diverse local economies, the alleviation of poverty, and providing meaningful social benefits. The APICDA Infrastructure Grant (AIG) provides financial assistance for infrastructure development in communities where development in the region is costly and a logistical challenge.

This grant assists communities by providing a funding source to help leverage grant funds from state, federal or private funders for community-initiated infrastructure development projects. Applicants must solicit and obtain majority funding (50% or more) for the project from other non-APICDA sources. Applications must be for infrastructure development defined as structures and/or facilities for development or repair/replacement of roads, water, power, wastewater, harbors, docks, or community/municipal buildings (i.e., clinics, community centers, warehouses, shops, etc.). Grants are approved by the APICDA Board of Directors and awarded once per calendar year.

The Miscellaneous Grant supports cultural and other enrichment activities at the community-wide level. This discretionary grant can be used to fund meaningful projects that don't fit within the scope of APICDA's established programs.

The miscellaneous grant funds up to \$5,000 per community and can be granted in installments throughout the year. Grant requests are received on a rolling basis and are accepted once they receive recommendations from the local APICDA Community Liaison Officer and the APICDA Board Member. Requests should provide a project outline and date when funding is needed.


